## LISTING CONTRACT

The Broker is authorized full access to the vessel for purposes of showing the vessel and to advertise the vessel and do such other acts as Broker reasonably deems appropriate to bring about a sale. Broker will use commercially reasonable efforts to bring about a sale, but results are not guaranteed. Seller represents that Seller is the owner of the vessel and authorized to enter this binding contract. It is agreed that upon the close of the sale the Seller will pay the Broker 6% out of the gross sale proceeds. This rate only applies as exclusive listings and payment will be in full and made payable to **Top Shelf Marine Sales, Inc.** In the event of a sale by Seller (without Broker's efforts) directly to any person listed on Addendum A as a pre-existing contact of Seller, the commission rate will be waived and replaced with a rate/amount of **\$100.00**. The \$100.00 fee is to offset the costs of listing and promotion incurred by Broker and is payable upon the time of listing the vessel. If the vessel is sold to any person not listed on Addendum A or sold using Broker's efforts to a person listed on Addendum A, the full commission rate will apply. This is an exclusive listing agreement, and the vessel cannot be listed with another broker, agent or other person, including on a houseboat manufacturer website, during the term of this contract.

Sales deposits accepted by the Broker are deemed non-refundable and in the event of forfeiture by the issuer shall become the property of the Seller less 15%. The 15% deducted from forfeited deposits become the property of the Broker to cover administrative costs.

In the event of a sale within ninety (90) days of the notice of termination permitted above, the full and entire commission rate will apply.
